

## HSBC Finance Mastercard® Rates and Fees Information Box

<p><b>Annual Interest Rates</b></p>	<p>These interest rates are in effect on the day your HSBC Mastercard account (“Account”) is activated.</p> <p style="padding-left: 40px;">Purchases and fees:     <b>22.9%</b></p> <p style="padding-left: 80px;">Cash Advances:         <b>22.9%</b></p> <p style="padding-left: 40px;">Balance Transfers:     <b>22.9%</b></p> <p style="padding-left: 80px;">Cheques:                <b>22.9%</b></p> <p><b>Late or Missed Payments</b></p> <p>If you do not pay the Minimum Payment in full by the due date on your Account statement two billing periods in a row (the “<b>first</b>” and “<b>second</b>” billing periods), your interest rates in effect at the end of the third billing period will increase by <b>5%</b> per year. The increased rates will apply on the <b>first</b> day of the <b>fourth</b> billing period and will continue to apply until you qualify for a rate decrease.</p> <p>If you pay the Minimum Payment in full by the due date on your Account statement six billing periods in a row (the “<b>first</b>” through “<b>sixth</b>” billing periods), your previously increased rates in effect at the end of the seventh billing period will decrease by <b>5%</b> per year. The decreased rates will apply on the <b>first</b> day of the <b>eighth</b> billing period.</p> <p><b>Example:</b> Your billing periods end on the last calendar day of each month and your Minimum Payments become due on the 22<sup>nd</sup> calendar day of each month. If you miss or are late to make Minimum Payments that become due in <b>December</b> and <b>January</b>, your rates in effect on the last day of February will go up by <b>5%</b> per year starting on the <b>first</b> day of <b>March</b>. An annual interest rate of <b>22.9%</b> will increase to <b>27.9%</b>.</p> <p>If you pay each Minimum Payment that becomes due in <b>March</b> through <b>August</b> in full and on time, your previously increased rates in effect on the last day of September will decrease by <b>5%</b> per year starting on the <b>first</b> day of <b>October</b>. An annual interest rate of <b>27.9%</b> will decrease to <b>22.9%</b>.</p>
<p><b>Interest-free Grace Period</b></p>	<p><b>21</b> days</p> <p>You will benefit from an interest-free grace period on new Purchases and fees of at least <b>21</b> days if you pay off your balance in full by the due date.</p> <p>There is no interest-free period on Cash Advances, Balance Transfers and Cheques.</p> <p>Interest begins to accrue on Purchases, Cash Advances and fees from the date of the transaction and on Balance Transfers and Cheques from the date posted.</p>
<p><b>Minimum Payment</b></p>	<p>Your minimum payment is the greater of <b>3%</b> of the total outstanding amount (rounded to the next dollar) or <b>\$10</b>, plus all past due amounts and amounts over your credit limit. If the total outstanding amount is less than <b>\$10</b>, then the Minimum Payment is equal to the total outstanding amount.</p>

<b>Foreign Currency Conversion</b>	<p><b>2.5%</b></p> <p>We will bill you in Canadian currency if you use your Account to make transactions in foreign currency. If you make (or return) Transactions in a foreign currency, we convert the amount to Canadian dollars at the conversion rate that is <b>2.5%</b> above a benchmark foreign currency exchange rate determined by Mastercard that is in effect and that we must pay on the date we post the Transaction to the Account. This rate may be different from the rate in effect on the date you made the Transaction.</p>
<b>Annual Fees</b>	<p><b>\$59</b></p> <p>To be charged upon enrolment and annually on your anniversary date.</p>
<b>Other Fees</b>	<p>To be charged on the date of the transaction:</p> <ul style="list-style-type: none"> <li>• Cash Advance fees (do not apply in Quebec): <ul style="list-style-type: none"> <li>• Automated Teller Machine (ATM) displaying the Mastercard or Cirrus® symbol – ATM in Canada – <b>\$2</b>; ATM outside Canada - <b>\$4</b></li> <li>• Over-the-Counter (in Branch) at a Mastercard Financial Institution - In Canada - <b>\$3</b>; Outside Canada - <b>\$5</b></li> </ul> </li> <li>• Wire transfers, travelers cheques, foreign currency, money orders, payment of an existing debt, bets, lottery tickets, and casino gaming chips (referred to as “quasi-cash transactions”); fees do not apply in Quebec: <b>\$2.75</b></li> </ul> <p>To be charged on the date the transaction is posted:</p> <ul style="list-style-type: none"> <li>• Charge for dishonoured payment or dishonoured Cheque: <b>\$25</b></li> <li>• Cheque fee - for Cheques written to a merchant outside Canada: <b>\$5</b></li> <li>• Extra copy of your monthly statement or sales slip: <b>\$10</b></li> <li>• Promotional Offer Balance Transfer fee: Up to <b>5%</b> of the balance transfer amount. We charge this fee when we offer a promotional interest rate on balance transfers for a specified period which is lower than the annual interest rate that applies to balance transfers to your Account. We may waive or lower this <b>5%</b> fee at the time the promotional interest rate offer is made to you. We do not charge balance transfer fees outside of promotional offers.</li> <li>• Rush card or PIN replacement fee: for courier delivery within Canada: <b>\$25</b></li> </ul> <p>To be charged on the statement date:</p> <ul style="list-style-type: none"> <li>• Over the credit limit fee – if your balance exceeds your assigned credit limit during the statement period (the fee does not apply in Quebec): <b>\$29</b></li> </ul>
