

This document contains key information you should know about the Manager Series of the HSBC Wealth Compass Conservative Fund (the "Fund"). You can find more details in the Fund's simplified prospectus. Before you invest in any fund, you should consider how it would work with your other investments and your tolerance for risk.

On December 10, 2018, the manager of the Fund, HSBC Global Asset Management (Canada) Limited, determined that it does not expect the Fund to qualify as a mutual fund trust for tax purposes for 2018 by the required deadline, which is the end of March 2019. As a result, the Fund will be taxed differently than other funds that are mutual fund trusts. This will result in the application of the mark-to-market rules to the Fund and unitholders may receive larger income distributions than expected. For a more detailed explanation of how the Fund is taxed when it is not a mutual fund trust, and the impact on unitholders, please refer to the Fund's Simplified Prospectus and Annual Information Form.

What does this Fund invest in?

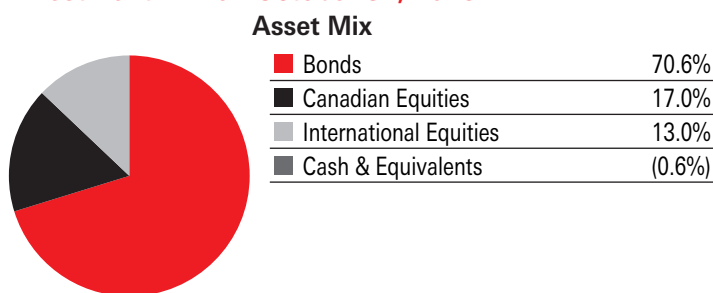
The Fund invests in a diversified portfolio of other mutual funds and/or ETFs, and uses strategic asset allocation as the principal investment strategy. The Fund has an established asset mix, based on its stated objectives. The portfolio manager may adjust the Fund's asset mix depending on economic conditions and the relative value of securities in the Fund.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much the Fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

HSBC Global Asset Management (Canada) Limited has rated the volatility of this Fund as **low**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how the Manager Series units of the Fund has performed since inception. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Who is this Fund for?

This Fund might be suitable for investors who:

- want to earn interest income
- seek some potential for low to moderate long-term growth of capital
- have a medium investment time horizon
- have a low tolerance for risk

! It is not suitable for investors with a short investment time horizon.

A word about tax

In general, you pay tax on your share of the Fund's taxable earnings and capital gains you realize from redeeming your investment. The amount of tax depends on the tax rates that apply to you, and the type of earnings realized by the Fund (e.g. interest, dividends, capital gains, etc.) and whether or not you hold your investment within a registered retirement savings plan or other registered plan.

Keep in mind that if you hold your investment outside of a registered plan, you will receive a tax slip that shows your share of the Fund's earnings. You must report your share of the taxable earnings in your taxable income, whether you receive them in cash or have them reinvested. In addition, you must calculate your taxable capital gains realized on redemption.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell units of the Manager Series of the Fund. The fees and expenses — including any commissions — can vary among the series of the fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

No sales charges apply to the Manager Series units of the Fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's return. The Fund's expenses are made up of the management fee, operating expenses and trading costs. The Manager Series' annual management fee is 0.40% of the Manager Series' value. Because the Fund is new, its operating expenses and trading costs are not yet available.

3. More about the trailing commission

HSBC Global Asset Management (Canada) Limited does not pay your representative a trailing commission for the Manager Series units you own of the Fund.

4. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
Short-term trading fee	Up to 2% of the value of units you sell or switch within 30 days of your most recent purchase of the units, or if you switch among the funds excessively. This fee goes to the Fund.
Switch fee	Your representative may charge you up to 2% of the value of units you purchase when you switch your units to another fund, or to another series of the same Fund.
Fee-for-service	The Manager Series units of the Fund are available to investors who are enrolled in a "fee-for-service" program where you pay your representative directly an annual asset-based fee for investment advice.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
